The undersigned, for the purposes of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation.

## ARTICLE ONE NAME

The name of this corporation is: CAMP NEBRASKA, INC.

## ARTICLE THREE CORPORATE DURATION
