The undersigned subscriber to these Articles of Incorporation a natural person competent to contract hereby resolves to form a corporation under the laws of the State of Florida. TALLAHASSEE, FLORIDA

ARTICLE I

The name of the corporation is "RON KUNZMAN PHOTOGRAPHY, INC."

ARTICLE II

The powers, purpose and nature of the business to be transacted by this corporation shall be: The conduct of any lawful business or businesses in any form or combination thereof and to finance the same in any form or combination thereof either within or without the State of Florida, The United States of America, or any other Foreign country or countries.

ARTICLE III

The capital stock of this corporation shall consist of one -thousand (1000) shares of common stock with a par value of one dollar (\$1.00) per share.

ARTICLE IV

The corporation is to exist perpetually.

ARTICLE V
