ARTICLES OF INCORPORATION OF BASILOTTO ENTERPRISES, INC.

ARTICLE I - NAME AND MAILING ADDRESS

The name of this corporation is Basilotto Enterprises, Inc.

The mailing address is 299 Washington St. Englewood, F1. 34223.

This corporation shall exist perpetually.

ARTICLE III - PURPOSE
This corporation is organized for the purpose of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.


