ARTICLES OF INCORPORATION

OF

ALL COAST TREE SERVICE, INC.



ARTICLE ONE

The name of this corporation is ALL COAST TREE SERVICE, INC. and the mailing address of the corporation shall be 4549 Gulf Avenue, Fort Myers, FL 33903.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

ARTICLE THREE

The duration of the corporation is perpetual.

ARTICLE FOUR

The general purposes for which the corporation is organized are:

- 1. To engage in the business of commercial tree service.
- 2. To transact any other lawful business for which corporation may be incorporated under the Florida General Corporation Act.
