**ARTICLE I - 1038 NOVEMBER, INC.**

The name of this corporation is 1038 NOVEMBER, INC.

**ARTICLE II - PURPOSES**

This corporation is organized for the purpose of transacting any or all lawful business pursuant to the provisions of Chapter 607, Florida Statutes.

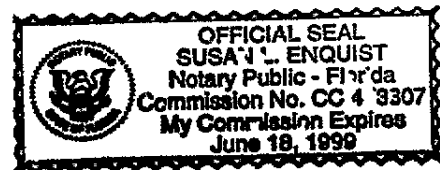

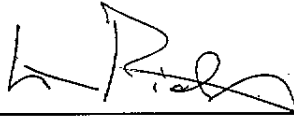
