We, the undersigned subscribers to the Articles of Incorporation, do hereby

**ARTICLE I: NAME**

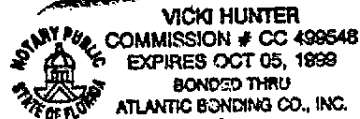
