Please find enclosed our Profit Corporation Annual Report for 1999, with the proper fee amount of \$150.00.

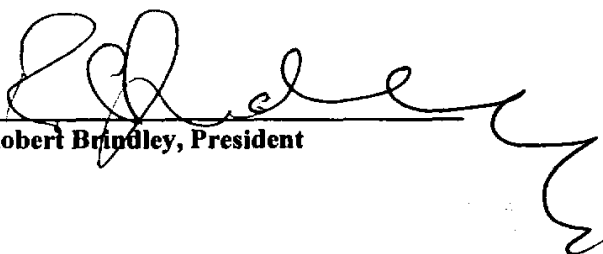
