ARTICLES OF INCORPORATION

OF

CHUCK'S MOBILE SERVICE, INC.

The undersigned, desiring to organize a corporation under Chapter 607, Florida Statutes, sets forth the following:

ARTICLE I

The name of the corporation shall be Chuck's Mobile Service, Inc. The address of the principal office of the corporation and the mailing address of the corporation is 3206 Vinewood Lane, Jacksonville, FL 32277.

The duration of the corporation shall be perpetual.
