**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF WEST PALM BEACH TECHNOLOGIES, INC.,
A FLORIDA CORPORATION**

In accordance with the terms of Section 607.1006 of the Florida Business Corporation Act (the "Act"), WEST PALM BEACH TECHNOLOGIES, INC., a Florida corporation, hereby adopts the following amendment to its Articles of Incorporation:

Article V is hereby amended to read as follows:

**ARTICLE V
CAPITAL STOCK**

The maximum number of shares of stock which this Corporation is authorized to issue is 50,000,000 shares of common stock having a par value of \$.001 per share.

In accordance with Section 607.1003 of the Act, the foregoing amendment to the Articles of Incorporation of the Corporation was adopted by means of a Written Consent of the Sole Director and Shareholder of the Corporation dated June 1, 1998, and therefore, the number of votes cast in favor thereof was sufficient for its approval.
