

ARTICLES OF INCORPORATION

OF



MASOUD KETABCHI, M.D., P.A.

The undersigned, for purposes of forming a professional corporation under the provisions of §607, the Florida Business Corporation Act (1993) and §621 the Professional Service Corporation Act, (1993), adopts the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be MASOUD KETABCHI, M.D., P.A. (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the office of the Corporation is 7245 Gleneagle Drive, Miami Shores, Florida 33014.

ARTICLE III

The general purpose for which the corporation is organized is to engage in every aspect of the practice of medicine.
