ARTICLES OF INCORPORATION

OF

INTEGRITY PAINTING OF N.W. FLORIDA, INC.

ARTICLE I - NAME:


The power to adopt, alter, amend or repeal the By-Laws shall be vested in the Board of Directors and the shareholders.
