**ARTICLES OF INCORPORATION
OF**

ARTICLE I - NAME

The name of this corporation is HERITAGE YACHTS, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.
