ARTICLE I - NAME

The Corporation's name is Dr. Nicole A. Rothman, P.A.

ARTICLE II - PURPOSE

The Corporation's purpose is to engage in the practice of chiropractic within the State of Florida, and to take all actions that are necessary or proper in connection with that practice.

ARTICLE III - PRINCIPAL OFFICE

The Corporation's street and mailing address of its initial principal office is 410 Asbury Way, Boynton Beach, Florida 33426.

ARTICLE IV - PROFESSIONAL SERVICES

The professional services of the Corporation shall be rendered only through officers, employees, and agents who are duly licensed or otherwise legally authorized to practice chiropractic within the State of Florida. Professional services shall be rendered in each case by the officer, employee, or agent designated solely by the Corporation, acting through its duly elected officers. This provision shall not be applicable to the extent it is in conflict with the law or professional rules of chiropractic practice.

ARTICLE V - CAPITAL STOCK

The Corporation is authorized to issue 7,500 shares of stock, with a par value of \$1.00 per share.


ARTICLE VI - INITIAL OFFICE AND AGENT


