ARTICLES OF INCORPORATION
OF
ORANGE LAKE LAUNDRY, INC.

ARTICLE I- NAME

The name of this corporation shall be ORANGE LAKE LAUNDRY, INC..

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III- PURPOSE

This corporation is organized for the purpose of transacting self service laundry operations , in addition to any and all lawful business permitted under the laws of the United States and the state of Florida.

ARTICLE IV- CAPITAL STOCK

This corporation is authorized to issue 100 shares of, single class of common stock, zero dollar (\$0) par value stock, which shall be distributed to Charles William Baddeley, which shall be designated as single class common stock.

ARTICLE V- PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
