OF

The undersigned, acting as incorporator of the captioned corporation under Chapter 607 of the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is SEDULOUS, INC. and its principal office and mailing address is 220 South Franklin Street, Tampa, Florida, 33602.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on February 1, 1998.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

By-Laws






