ARTICLE I - NAME

The name of the corporation is A & A MEDIA CONSULTANTS, INC.

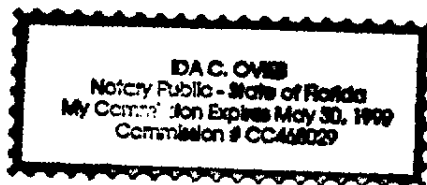
