ARTICLES OF INCORPORATION OF PAXSON SPOKANE LICENSE, INC.

The undersigned, acting as incorporator of PAXSON SPOKANE LICENSE, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

ARTICLE III. COMMENCEMENT OF EXISTENCE


The existence of the corporation will commence at 8:00 A.M. on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.
