**ARTICLES OF INCORPORATION
General Distribution Services Corp.**

ARTICLE I

The name of this corporation is General Distribution Services Corp. Whose principal address is 4800 N. Federal Hwy, Lighthouse Point, Florida 33064.

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage as a distributor of electrical parts a business permitted under the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.

ARTICLE IV

This Corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation.



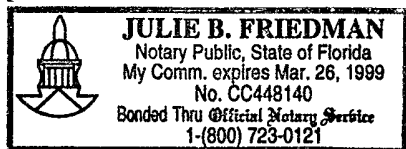
