ARTICLES OF INCORPORATION OF WACHOVIA TRUST COMPANY

ARTICLE I

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopts the following Articles of Incorporation.

The name of the Corporation shall be Wachovia Trust Company and its initial place of business shall be at 180 Royal Palm Way, in the City of Palm Beach, in the County of Palm Beach and State of Florida.

ARTICLE II

The general nature of the business to be transacted by the Corporation shall be that of a general trust company business with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes regulating the organization, powers, and management of trust corporations.

ARTICLE III

The total number of shares authorized to be issued by the Corporation shall be 5,000,000. Such shares shall be of a single class and shall have a par value of \$1.00 per share. The Corporation shall begin business with at least \$1,050,000.00 in paid-in common capital stock to be divided into 1,050,000 shares. The amount of surplus with which the Corporation will begin business will be not less than \$820,000.00 and the amount of undivided profits, not less than \$200,000.00 all of which (capital stock, surplus, and undivided profits) shall be paid in cash.

ARTICLE IV

The term for which the Corporation shall exist shall be perpetual unless terminated pursuant to the Florida Financial Institutions Codes.

ARTICLE V

The business of the Corporation shall be managed by a Board of Directors which shall not be fewer than five (5). The names and street addresses of the first directors of the Corporation are:

ARTICLE VI

The Corporation shall have a President, a Secretary and a Treasurer and may have additional and assistant officers including, without limitation thereto, a Chairman of the Board of Directors, one or more Vice Presidents, Assistant Secretaries and Assistant Treasurers. A person may hold more than one office.

ARTICLE VII

The Board of Directors shall adopt By-Laws for the Corporation. The By-Laws may be amended, altered or repealed by the shareholders or Directors in any manner permitted by the By-Laws.

ARTICLE VIII

The Corporation shall, to the fullest extent authorized or permitted by the Florida Statutes, as the same may be amended or modified from time to time, indemnify any officer, Director, employee or agent or former officer, Director, employee or agent or the heirs, executors or administrators of such person who was or is a party to any proceeding against such person by reason such person's acting on behalf of the Corporation against (a) in the case of any proceeding other than an action by or in the right of the Corporation, liability incurred in connection with such proceeding including any appeal thereof, or (b) in the case of any proceeding by or in the right of the Corporation, expenses and amounts paid in settlement not exceeding, in the judgment of the Board of Directors, the estimated expense of litigating the proceeding to conclusion; provided, however, that the Corporation shall not indemnify any officer, Director, employee or agent if a judgment, settlement or other final adjudication establishes that the officer's, Director's, employee's or agent's actions or omissions to act were material to the cause of action so adjudicated and constitute:

- (A) a violation of criminal law, unless the officer, Director, employee or agent had reasonable cause to believe his or her conduct was lawful or had no reasonable cause to believe his or her conduct was unlawful;
- (B) a transaction from which the officer, Director, employee or agent derived an improper personal benefit, either directly or indirectly;
- (C) in the case of a Director, a circumstance under which the liability provisions of F.S. Section 607.0834, governing a Director's liability for unlawful distribution to shareholders, is applicable; or
