- 1. The name of the Corporation is currently Advanced Multimedia Group, Inc.
- 2. The Articles of Incorporation are amended as follows:
- a. By deleting all of Article V of the Articles of Incorporation, and by substituting in lieu thereof, all of the following:

"The aggregate number of shares which this corporation shall have authority to issue is the total sum of 40,000,000 shares, having an individual par value of \$.001.

Unless otherwise stated in these articles, or in an amendment to these articles, there shall be only one (1) class of stock of this corporation."

- b. In all other respects, the Articles of Incorporation shall remain unchanged.
- 3. This Amendment was adopted by a written statement signed by the sole shareholder and the sole director of the Corporation on June 24, 1999, pursuant to Section 607.1003 of the Florida Statutes.
- 4. The effective date of this Amendment shall be upon the filing of these Articles of Amendment to Articles of Incorporation with the Secretary of State of the State of Florida.
