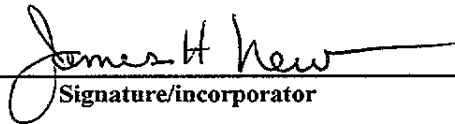

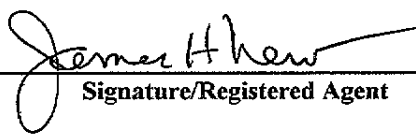
ARTICLE VII INDEMNIFICATION
