Pursuant to the provisions of Section 607.1006, Florida Statutes, HVIDE MARINE TOWING SERVICES, INC., a Florida corporation, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- FIRST:** Article I is hereby amended to read as follows:
- “The name of the corporation (hereinafter referred to as the “Corporation”) is Seabulk Towing Services, Inc.”
