ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF





Pursuant to Sections 607.1005 and 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned sole director of Natel Communication Services, Inc., a Florida corporation (the "Corporation"), hereby executes and submits for filing with the Department of State of the State of Florida these Articles of Amendment to the Articles of Incorporation of the Corporation to read as follows:

FIRST:

The name of the Corporation is NATEL COMMUNICATION SERVICES,

INC.

SECOND: Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following is inserted in lieu thereof:

ARTICLE I. NAME

The name of the corporation is **ORIUS TELECOMMUNICATION HOLDINGS (WI)**, **INC.**

THIRD: The above amendment to Article I was adopted by the sole director of the Corporation on April 1, 2001.

FOURTH: The above amendment was adopted by the sole director of the corporation without shareholder approval, which is not required pursuant to Section 607.1005 of the Act.
