**ARTICLES OF INCORPORATION**

The undersigned, desiring to form a Corporation in accordance with the laws of the State of Florida, adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the Corporation shall be INSIGHT INVESTIGATIVE GROUP, INC.

**ARTICLE II - REGISTERED OFFICE AND PRINCIPAL PLACE OF BUSINESS**

The street address of the initial registered office, principal place of business, and mailing address of the Corporation shall be 12220 S.W. 109<sup>TH</sup> Avenue, Miami, Florida 33176.

**ARTICLE III - NAME AND ADDRESS OF REGISTERED AGENT**

The name and address of the initial registered agent of the Corporation is Jed A. Burger, 12220 S.W. 109<sup>TH</sup> Avenue, Miami, Florida 33176.

**ARTICLE IV - NATURE OF BUSINESS**

The purpose for which this Corporation is organized shall be to engage in every aspect of the practice of law, investigation, consulting, training, and research. This Corporation may also engage in or transact any or all other lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

**ARTICLE V - DURATION**

The term of existence of this Corporation is perpetual, which shall commence upon the filing of these Articles of Incorporation with the Secretary of State of the State of Florida.

**ARTICLE VI - CAPITAL STOCK**

The aggregate number of shares which the Corporation is authorized to have outstanding is 500, all of which shall be common shares, with a par value of \$1.00 per share. All stock shall be payable in cash, property, real or personal, or labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this Corporation.

**ARTICLE VII - DIRECTORS**

This Corporation shall have at least one director, with the exact number of directors to be specified by the shareholders from time to time unless the shareholders shall, by a majority vote hereafter, determine that the Corporation shall be managed by the shareholders. **ARTICLE IX - SHAREHOLDER LIABILITY**

The private property of the shareholder shall not be subject to the payment of the Corporate debts to any extent whatsoever.

**ARTICLE X - INDEMNIFICATION**

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law for such acts of the officer or director, or former officer or director, while acting on behalf of the Corporation.

**ARTICLE XI - AMENDMENT OF ARTICLES**

The Corporation reserves the right to amend these Articles of Incorporation at any time in a manner now or subsequently permitted by applicable law.


