ARTICLES OF INCORPORATION OF BARGAIN & TREASURES, INC.

THE UNDERSIGNED, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

WITNESSETH:

ARTICLE I NAME

The name of the Corporation is:
