ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms this corporation under the laws of the State of Florida, Part II, General Corporation Law.

ARTICLE I  
Name

The name of the corporation is: ASSOCIATED ATTORNEYS' CONFIDENTIAL REFERRAL SERVICE, INC..

ARTICLE II  
Duration

The period of duration of the corporation is perpetual.

ARTICLE III  
Purpose

The purpose or purposes for which the corporation is organized are to engage in any lawful business including attorney's referral service, and to do everything necessary, proper, advisable or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the Florida corporation laws or by other law, or by these Articles of Incorporation, and to carry out the said purposes in any state, territory, district or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of that state, territory, district or possession of the United States, or by the foreign country.

ARTICLE IV  
Authorized Shares

1. Number: The aggregate number of shares that the corporation shall have the authority to issue is 7,500 shares of Capital Stock with a par value of ONE DOLLAR (\$1.00) per share.

2. Initial Issue: One hundred (100) shares of the Capital Stock of the corporation shall be issued for cash at a par value of ONE DOLLAR (\$1.00) per share.

3. Stated Capital: The sum of the par value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

4. Dividends: The holders of the outstanding Capital Stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the Capital Stock of the corporation.

5. No Classes of Stock: The shares of the corporation are not to be divided into classes.

6. No Share In Series: The corporation is not authorized to issue share in series.

ARTICLE V  
Initial Registered Office and Agent

The initial street address in Florida of the initial registered office of the corporation 1156 7th Street N.W., Largo, Pinellas County, Florida and the name of the initial registered agent at such address is MARADENE GIVENS ARNOLD.

ARTICLE VI  
Board of Directors

The initial Board of Directors shall consist of not less than one (1) nor more than five (5) members, who need not be residents of the State of Florida nor shareholders of the corporation.

ARTICLE VII  
Initial Directors

The names and addresses of the persons who shall serve as directors until the first annual meeting of shareholders, or until their successors shall have been elected and qualified are as follows:

ARTICLE IX  
Shareholder Action

A majority of the Stockholders of the corporation shall be required for any stockholder action except as otherwise expressly provided for in Article XI of these Articles of Incorporation.

ARTICLE X  
Power to Adopt, Amend, Alter, Change or Repeal Articles

The shareholders shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a stockholders' meeting, with not less than a majority vote of the common stock.

ARTICLE XI  
Preemptive Rights to Purchase Shares

1. The shareholders of the corporation shall have preemptive rights to acquire their pro rata share of stock of the corporation for all issues, of any class of stock of the corporation, no matter when authorized, and for whatever consideration is contemplated to be received by the corporation, including but not limited to cash, other property, services, the acquisition of other corporations shares or property through merger or the extinguishment of debts. Preemptive rights shall apply to the reissuance of all redeemed or otherwise acquired shares, including the reissuance of treasure shares.

2. This article pertaining to preemptive rights may not be amended or deleted without the unanimous vote of the shareholders of each affected class.

3. No issue of stock of the corporation shall take place unless the price at which the stock is to be issued shall be unanimously approved by the shareholders of the corporation.

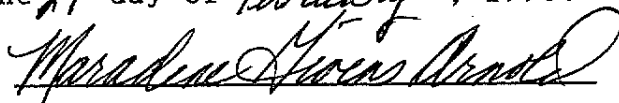
ARTICLE XII  
Voting of Shares Comulatively

The shareholders of this corporation shall be allowed to vote their shares cumulatively so as to give one candidate as many votes as the number of directors to be elected multiplied by the number of his shares, to distribute them among as many candidates as he may wish. Notice must be given by any shareholder to the President or a Vice President of said corporation not less than twenty-four (24) hours prior to the time set for the holding of a shareholders' meeting for the election of directors that said shareholder intends to cumulate his vote at said election.

ARTICLE XIII  
Street Address

The principal place of business of this corporation shall be located at 1156 7th Street N.W., Largo, Pinellas County, Florida 33770, or at such places within or without the State of Florida as the Board of Directors shall, by appropriate action, from time to time determine.

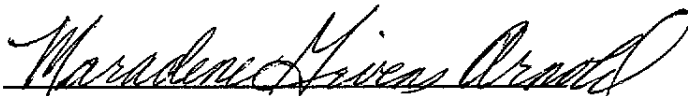
