SECRETARIA SONO DE LA CONTRACTOR DE LA C We, the undersigned, hereby make, subscribe, acknowledge and file these Articles for the purpose of becoming a corporation under the laws of the State of Florida.

# **ARTICLE I**

The name of the corporation is LAKE JEM FARMS, INC.

# **ARTICLE II**

The corporation shall have perpetual existence.
