ARTICLE I - NAME

The name of this Corporation is PASCUAL DAIRY, INC. and its address is 2100 Ponce de Leon Boulevard, Suite 1180, Coral Gables, FL 33134.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.
