**ARTICLES OF INCORPORATION
OF
PAXSON COMMUNICATIONS OF SAN ANTONIO-26, INC.**

The undersigned, acting as incorporator of PAXSON COMMUNICATIONS OF SAN ANTONIO-26, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:

PAXSON COMMUNICATIONS OF SAN ANTONIO-26, INC.

ARTICLE II. ADDRESS

The mailing address of the corporation is:

West Palm Beach, Florida 33401

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence at 8:00 A.M. on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 601 Clearwater Park Road, West Palm Beach, Florida 33401-6233, and the name of the corporation's initial registered agent at that address is William L. Watson, Esq.

ARTICLE VII. INITIAL BOARD OF DIRECTORS

The corporation shall have one director initially. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than one. The name and street address of the initial director is:

ARTICLE VIII. INCORPORATOR

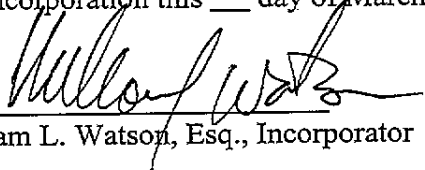
ARTICLE IX. BYLAWS

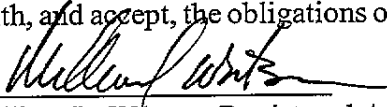
