The undersigned subscriber, being the sole shareholder and director of ADVANCED COMMUNICATIONS CONSULTANTS, INC., a Florida corporation, hereby amends the Articles of Incorporation of ADVANCED COMMUNICATIONS CONSULTANTS, INC., as originally filed March 27, 1998, in accordance with Florida Statutes Chapter 607, in the following manner to effectuate a change of the name of the corporation to "ANSWER FLORIDA, INC.":

I. Article I of said Articles of Incorporation shall be deleted and a new Article I shall be substituted therefor as follows:

"ARTICLE I

The name of this corporation is ANSWER FLORIDA, INC."

II. The date of the adoption of this Amendment is DECEMBER 31, 1998.

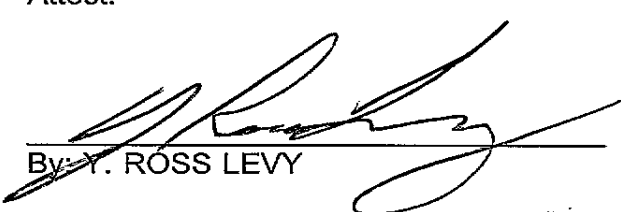
III. This Amendment has been authorized by the sole Director of the Corporation and is approved by the Corporation's sole shareholder, Y. ROSS LEVY.

IV. In all other respects, the undersigned ratifies and confirms the original Articles of Incorporation as filed March 27, 1998.

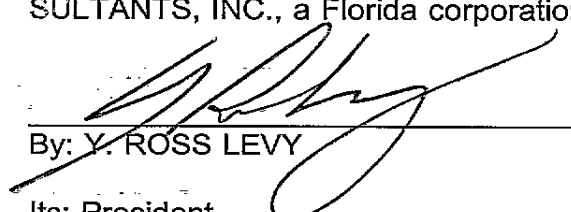

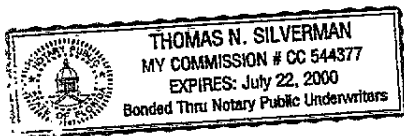
