The undersigned hereby organize a corporation for profit under the provisions of the Florida General Corporation Act, and pursuant to the following Articles of Incorporation.

**Article I**

Name

The name of the corporation is:

**Article II**

Duration

This corporation shall have perpetual existence, commencing upon filing.

**Article III**

Purpose

This corporation is organized for the purpose of transacting any and all lawful business.

**Article IV**

Capital Stock

This corporation is authorized to issue Nine Hundred (900) shares of common stock with no par value.

## Article V

### Preferences, Privileges, Restrictions and Rights

Each share of common stock confers the same rights and privileges as conferred by all other shares of common stock.

## Article VI

### Preemptive Rights

Every share holder, upon the sale for cash on any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the same price it is offered to others.
