# ARTICLES OF INCORPORATION OF CHAMBERLAIN ADVANTAGE, INC.



The undersigned, for the purposes of forming a corporation under the Florida general Corporation Act, hereby adopt the following Articles of Incorporation.

#### ARTICLE ONE NAME

The name of the corporation is Chamberlain Advantage, Inc.
