ARTICLES OF INCORPORATION

APOCALYPSE SKATEBOARD, INC.

ARTICLE ONE

The name of the corporation is APOCALYPSE SKATEBOARD, INC..

ARTICLE TWO

The period of its duration is perpetual.

The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.



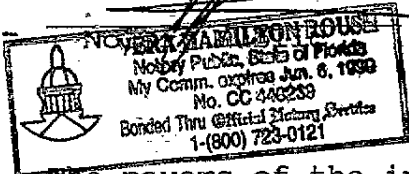




ARTICLE TEN
