## ARTICLES OF INCORPORATION OF G & R PAINTING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I The name of the corporation shall be G & R Painting, Inc. hereinafter referred to as the "corporation".

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III This corporation shall have all such powers as may be permissible to corporations under the laws of the State of Florida, and all powers necessary or desirable to accomplish the purposes and business of the corporation as hereinabove set forth in Article II.

<u>ARTICLE IV</u> This corporation has the authority to issue one thousand shares of common stock with a par value of one Dollars (\$1.00) per share.

ARTICLE V

This corporation is to exist perpetually.

ARTICLE VI

The initial street address of the principal office of this corporation in the State of Florida is: 975 17th Place SW, Vero Beach, FL 32962. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE VII
This corporation shall have one (1) director

This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time, as provided in the By-Laws.

ARTICLE VIII

The name and address of the members of the first Board of Directors is:

This director shall hold office until the first annual meeting or until her successors are elected or appointed and qualified as provided in the By-Laws. and qualified as provided in the By-Laws.

ARTICLE IX The name and address of the incorporator is:
Robert Garone 975 17th Place SW, Vero Beach, FL 32962 Unless otherwise provided in the By-Laws, every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others. The By-Laws may provided that every

offered to others. The By-Laws may provided that every stockholder is not to have the right to so purchase. The By-Laws may provide for cumulative voting for directors and may make provisions governing the issuance of stock certificates to replace lost or destroyed certificates. These directors shall be elected by the shareholder at each annual meeting and the officers shall be elected by the director at each annual meeting. The date of the

annual meeting shall be fixed by the By-Laws.

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by the majority of the stock entitled to vote thereon, unless all of the directors and all of the stockholders sign a written statement manifesting their intentions that a certain amendment of these Articles of Incorporation may be made.

ARTICLE XII

The registered agent for service of process within this state shall be Terry Goff of 1940 10th Avenue, Suite C, Vero Beach, FL 32960.
