ARTICLES OF INCORPORATION OF DEBBIE KRANAK & ASSOCIATES, INC.

I, the undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, do hereby make, subscribe, acknowledge, and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation shall be DEBBIE KRANAK & ASSOCIATES, INC. ("Corporation"). The Corporation shall have perpetual existence, commencing on the date of filing of these Articles of Incorporation in the Office of the Secretary of State of the State of Florida.

ARTICLE II PRINCIPAL OFFICE

The initial principal office and place of business and mailing address of this Corporation shall be: 1600 Bulevar Manor, Pensacola Beach, Florida 32561.

ARTICLE III REGISTERED OFFICE AND NAME OF REGISTERED AGENT
