ARTICLE I - NAME

The name of this Corporation is C & R ACQUISITION CORP. and its address is 2700 W. Atlantic Blvd., Suite 101, Pompano Beach, FL 33069.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


ARTICLE IX - INCORPORATOR


