The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The corporation shall commence its existence on April 8, 1998 and shall exist perpetually unless sooner dissolved according to law.


ARTICLE VIII - SHAREHOLDER PROPERTY


