ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation

ARTICLE I - NAME

The name of this corporation is SNC INTERNATIONAL CORP. The mailing address of the corporation is 1000 Quayside Terrace # 1608, Miami FL 33138

ARTICLES II - PURPOSE

The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida and the United States.

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of this Articles of Incorporation.

ARTICLE IV - Capital Stock

This corporation is authorized to issue 3,000 shares of \$1.00 per value Common Stock which shall be designated "Common Shares"

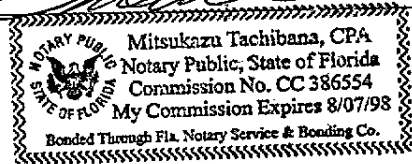
