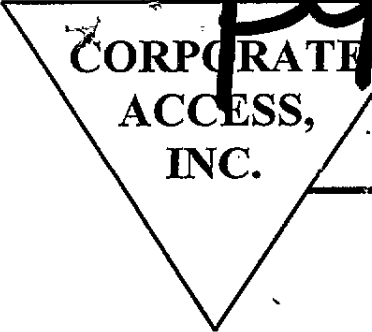

WHEREAS, the Articles of Incorporation of J & F Enterprises Company, USA were filed with and approved by the Secretary of State of the State of Florida on the 23rd day of April, 1998; and

WHEREAS, it is the intention of the sole incorporator of J & F Enterprises Company, USA that the Articles of Incorporation of J & F Enterprises Company, USA be amended effective April 23, 1998, in accordance with the proposed amendment hereinafter set forth; and

WHEREAS, no stock has been issued and no directors have been elected; and

WHEREAS, the approval of the Secretary of State of the State of Florida of the proposed amendment hereinafter set forth is hereby requested.

NOW, THEREFORE, the Articles of Incorporation of J & F Enterprises Company, USA are hereby amended effective April 23, 1998, by deleting in its entirety the present Article 1 and by substituting therefor the following, to-wit:

"The name of the Corporation shall be J & S Enterprises of Tampa, Inc."
