ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

ARTICLE I.

CORPORATE NAME

The name of this corporation is Biersack Property Management, Inc..

ARTICLE II.

ADDRESS OF CORPORATION

The address of the principal office of the Corporation, or the mailing address of the Corporation, if the principal office is not yet known, is 2640 Golden Gate Parkway, Suite 206, Naples, Florida 34105.

ARTICLE III.

EFFECTIVE DATE

04-22-98

DURATION

The corporation shall have perpetual existence, commencing on the date of the execution and acknowledgment of these Articles or upon filing.

ARTICLE IV.

PURPOSE

NUMBER AND CLASS OF STOCK



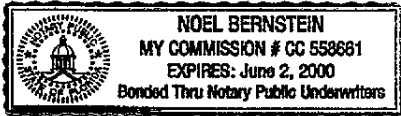
