**ARTICLES OF INCORPORATION  
OF  
ACCURATE GUN WORKS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

**ARTICLE ONE  
NAME & ADDRESS**

The name of the corporation is ACCURATE GUN WORKS, INC. Its principal office and place of business is located at 2250.S. Nova Road., Unit #2, South Daytona, Florida 32119.

**ARTICLE TWO  
CORPORATE DURATION**

The duration of the corporation is perpetual.

**ARTICLE THREE  
PURPOSE OR PURPOSES**

The general purposes for which the corporation is organized are:

1. To engage in the business of selling firearms, ammunition, holsters, archery supplies, apparel, self-defense products and merchandise that is typically associated with or related to the foregoing products.
2. To buy, sell, trade, manufacture, own, lease, operate, and maintain and to deal in and with goods, wares, and merchandise of every kind and nature, and to carry on such business as retailers, and to acquire all such merchandise, supplies, materials, and other articles as shall be necessary or incidental to such business; and to have any and all powers to carry out the purposes above set forth as fully as natural persons, whether as principals, agents, trustees, or otherwise.
3. To offer services typically described as gun smithing and custom gun smithing.
4. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of

5. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
