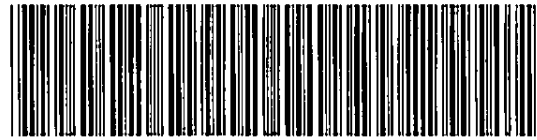




WHEREAS, it is hereby deemed to be advisable and in the best interests of this Corporation and its shareholders to increase its total authorized common shares.
