ARTICLE I - NAME

The name of this Corporation is DIAZ & SON, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing  
on June 4, 1998.

ARTICLE III - PURPOSE





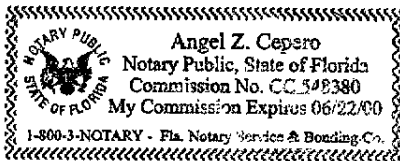
