**ARTICLE I - NAME**

The name of this Corporation shall be:  
Hot Rod Racing, Inc.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing  
on 06/01/98.

**ARTICLE III - PURPOSE**

This Corporation is organized for the purpose of transacting  
any and all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This Corporation is authorized to issue Two Hundred (200)  
shares of \$1.00 Par Value Stock.

**ARTICLE V - VOTING RIGHTS**

Except as otherwise provided by law, the entire voting power

thereof (as nearly as may be done without assurance of fractional  
shares) at the price at which it is offered to others.


#### ARTICLE X - BY-LAWS


