Date of Adoption

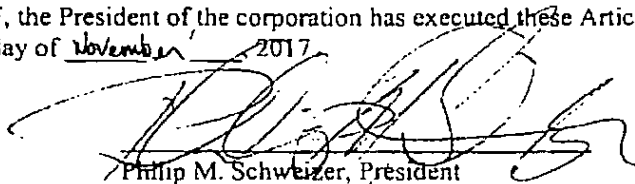
The amendment contained in these Articles of Amendment was adopted by resolution of the shareholders and directors of the corporation effective the 29th day of November, 2017.
