

The undersigned hereby makes, subscribes, acknowledges and files these Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I -- NAME

The name of the corporation shall be David J. Wiener, P.A.

ARTICLE II -- DURATION

The corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Secretary of State of Florida.

ARTICLE III -- PURPOSE

The purpose of this corporation is to engage in the practice of law and other activities permitted under the laws of the United States and Chapter 621 of the Florida Statutes, as amended from time to time.

ARTICLE IV -- CAPITAL STOCK
