## EFFECTIVE DATE

#### Article I

Name. The name of this Corporation is Quad-Line, Inc.

#### Article II

Principal Office. The address of the principal office of the Corporation is 4606 N. W. 108<sup>th</sup> Street, Gainesville, Florida 32606.

#### Article III
