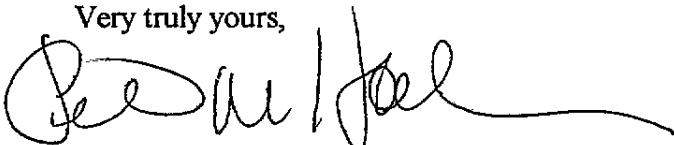

OF

ARTICLE I - NAME

The name of this corporation is STINGONE ELECTRIC, INC.

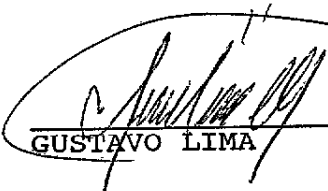

ARTICLE IX - AMENDMENT

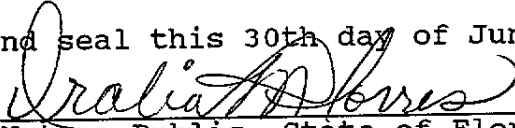

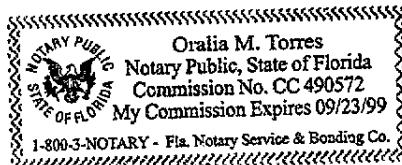

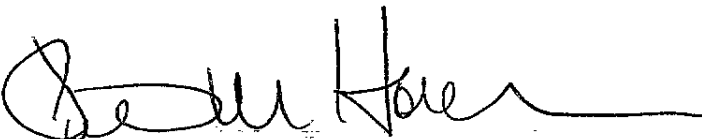
