The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - Name of Corporation

The name of this corporation shall be: Automated Preauthorized Checking Systems, Inc.

ARTICLE II - Duration

The term of existence of the corporation is perpetual, commencing upon the filing of these Articles of Incorporation with the Department of State, State of Florida.

ARTICLE III - Purpose and Powers

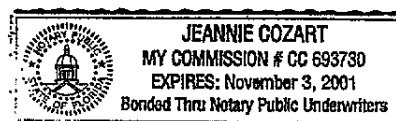
