**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
VCC CONSTRUCTION & DEVELOPMENT, INC.**

Pursuant to §607.1006, *Florida Statutes*, the undersigned, as President of VCC CONSTRUCTION & DEVELOPMENT, INC., a Florida corporation ("Corporation"), does hereby certify that the amendment provided for herein to change the name of the Corporation was adopted unanimously by written consents of the shareholders and board of directors of the Corporation pursuant to §607.0704 and §607.0821, *Florida Statutes*, on the 23rd day of August, 2000, and that the number of votes cast for the amendment by the shareholders was sufficient for approval.
